- Schooling Horse Trials ribbons and Best Score prizes will be given out based upon your combined scores from Dressage and Stadium. XC will be run as a schooling opportunity with designated ride times immediately following Stadium like a regular One Day.
- Ribbons 1st through 7th place.
- Prizes to 1st in all Divisions. Prizes to 1st through 3rd in full Divisions. Divisions (JR/YR, Amateur, Open) of less than 3 may be combined.
- Awards for each Best Scoring Morgan, Morgan Crossbred, Thoroughbred, Hanoverian, Overall Best Dressage Score and Best Scoring rider using an EQ Saddle Science saddle in any show phase!
- Flagged & flowered XC and the Dressage Courts will open after the show Saturday for additional schooling 30 minutes after the last Stadium round and all-day Sunday.
- Friday starting at noon both Dressage Courts will be open for schooling until 7PM. Hilltop Jumping warm up and XC jumping warm up in the West Arena also open at noon.
- Tentative Saturday Time Schedule: Dressage starts 7:30am, Stadium starts 9:00am, scheduled XC times start at 9:15am. We will try to have two dressage courts running to allow the show to wrap up earlier and allow more schooling time.
